### I. Introductions (Kenneth Thompson)

The meeting was called to order a 12:05 p.m. Kenneth welcomed attendees and facilitated introductions.

# II. Approval: June 2017 Minutes (Kenneth Thompson)

Darla moved to approve the minutes from the June 12<sup>th</sup> Planning Council Meeting. Doug seconded and the motion carried unanimously.

# III. Vote on New Planning Council Member: Mary Moran (Kenneth Thompson)

Kenneth introduced and provided background information on Mary. Kenneth made the nomination to name Mary as a new Planning Council member. Sandra seconded and the motion carried unanimously.

# IV. Strategic Planning - Discussion on Member Engagement and 2017 Work Plan (Kelly Nichols)

The final strategic plan is scheduled to be released in August. Kelly provided an update to the group regarding the changes to the identity statement. Key changes include adding the word "equity" to the vision statement, and removal of "public safety" from the mission statement.

Additionally, the issues areas have been updated to refer to the timeline of reentry as opposed to individual services because there are a variety of services that are needed in each point of reentry. The four issue areas are:

- Community Engagement
- Pre-Release
- Release
- Collateral Consequences.

One concern was raised that the four areas do not address jail diversion. The group will continue having

conversations about this to determine how and where this topic fits within the existing issue areas or if the issue areas should be expanded.

Attendees were divided into groups to brainstorm and discuss ways in which Planning Council members can encourage engagement and strengthen the leadership pipeline. One recommendation was to establish standing committees that focus on the four issues areas.

#### V. Misc. Announcements and Roundtable

Mario Espinoza provided a brief overview of the Central Texas Regional Mobility Authority and the work that the organization want to begin doing within the reentry sector. One of the biggest offerings the organization has is employment. These positions range from construction to commercial drivers.

Laura Sovine advised the group that a jail diversion program is in the works and that one individual will go through the program initially and will become the case study for future jail diversion practices.
